For those who choose to attend the meeting in person, the Board of License Commissioners asks that no one enter the hearing room before the scheduled time for the meeting. When entering the hearing room, please wear masks and adhere to social distancing requirements when taking your seat. Temperatures will be taken upon entrance to the hearing room and hand sanitizer provided. If more than 15 people desire to attend the meeting, admission to the hearing room will be first-come, first-admitted up to the 15-person limit. Those persons not admitted to the hearing room at first must wait in the hallway or outside the building for later admission. Audio of the hearing will be available in the hallway. Those admitted to the hearing room first must leave the hearing room after they have testified, at which time an equal number of persons waiting in the hallway will be allowed to enter the hearing room. Persons in the hearing room who elect not to testify must leave the hearing room upon the request of the Chair, so that others who wish to testify may enter.
