MEETING CALLED TO ORDER:

The meeting was called to order at 5:30 p.m.

PRESENTATIONS:

SUICIDE PREVENTION MONTH

Ms. Lauren Weber, Vice President of Philanthropy and Education spoke about Suicide Prevention Month.

Commissioner Steve Wilson read "Proclamation for Suicide Prevention Month"

Proclamation 22-47

WHEREAS, in the United States, one person dies by suicide every 11 minutes and is the 12th leading cause of death overall, and in Maryland, suicide is the 3rd leading cause of death for 10 -

34 year old and the 4th leading cause of death for ages 35 - — 44, and even though most of these deaths are preventable, on average, one Marylander dies by suicide every 13 hours, with more Marylanders dying by suicide than by homicide every year; and

WHEREAS, 45,979 people in the United States, including 585 people in Maryland, died by suicide in 2020, as reported by the Centers for Disease Control; and

WHEREAS, suicide affects us all, with each death by suicide affecting an average of 115 people, and

WHEREAS, in 2010, the combined medical costs and work loss costs of suicide in Maryland were determined by the Centers for Disease Control to equal \$586,391,000, or an average of \$1,168,110 per suicide death; and

WHEREAS, the 2019 Youth Risk Behavior Survey, conducted by local school systems in conjunction with the Center for Disease Control, revealed that at least one in five Mid-Shore teenagers ages 14 to 18 had seriously considered attempting suicide in the 12 months prior to the survey, with 25 percent reporting symptoms of depression, and rates of attempted suicide amongst Mid-Shore teens having risen 41 percent over the past decade; and

WHEREAS, according to the Center for Disease Control's Adolescent Behaviors and Experiences Survey, 37% of students at public and private high schools reported that their mental health was not good most or all of the time during the pandemic; and

WHEREAS, as reported by Brown University, nearly 4x as many adults report experiencing depressive symptoms than before the onset of the COVID-19 pandemic; and

WHEREAS, the World Health Organization (WHO) released a scientific brief in 2022 reporting that the global prevalence of anxiety and depression increased by 25% in the first year of the pandemic, and that anxiety and depression are leading precursors for suicide; and

WHEREAS, many individuals experiencing mental health symptoms, suicidal thoughts and behaviors, or who die by suicide never receive effective behavioral health services for many reasons, including the difficulty of accessing the services of healthcare providers professionally trained to reduce suicide risk, the stigma of seeking behavioral health treatment, and the stigma associated with losing a loved one to suicide, and urges all Queen Anne's County citizens to:

- 1. Support the development of accessible behavioral health services for all citizens of our county in an effort to reduce the risk of suicide and mental health challenges for people of all ages and backgrounds; and
- 2. Recognize suicide as a significant public health risk and to declare suicide prevention and mental health support a priority;

NOW, THEREFORE, WE, THE COUNTY COMMISSIONERS OF QUEEN ANNE'S COUNTY do hereby declare the month of October as No Matter What... You Matter Suicide Prevention Month and urge all citizens to actively work toward the prevention of suicide and to reach out to one another and ASK — "Are you okay?, LISTEN — without judgement, and SHARE — vital resources to promote an inclusive and mentally healthy community. GIVEN UNDER OUR HANDS AND THE GREAT SEAL OF QUEEN ANNE'S COUNTY, THIS 27TH DAY OF SEPTEMBER IN THE YEAR OF OUR LORD TWO THOUSAND AND TWENTY-TWO

QACEDT'S ANNUAL DESTINATION MARKETING ORGANIZATION GRANT FROM MARYLAND DEPARTMENT OF COMMERCE

Ms. Heather Tinelli presented to the Board documents for the Annual Destination Marketing Organization Grant from Maryland Department of Commerce for approval. Economic Development & Tourism receives grant funding from the state annually to support tourism marketing efforts focused on driving visitor traffic to the county. The amount of the grant award varies annually dependent upon a number of factors including hotel tax revenues and budgeted annual spending on tourism marketing. In prior years, the County received \$39,106 in FY22 and \$29,152 in FY21. Due to an additional \$8,000,000 in funding from the Governor's office awarded to Maryland Department of Commerce, we were awarded \$266,324 for FY23. EDT has received the grant agreement and award specifications and is confident that the department will be able to utilize the funds within the fiscal year as required. Due to the significant increase in grant funding a budget amendment is also requested.

REQUEST FOR ECONOMIC DEVELOPMENT INCENTIVE FUNDING – FOX ACUPUNCTURE AND WELLNESS, INC.:

Ms. Heather Tinelli presented to the Board the Economic Development Incentive Fund (EDIF) Commission's recommendation for the approval of a conditional loan of \$30,000 to Fox Acupuncture and Wellness for the expansion of the current wellness center, located at 133C Log Canoe Circle in Stevensville, Maryland. The expansion will start with the build-out of approximately 2,000 sq. ft. of space in the Chesapeake Bay Business Park, including at least six (6) treatment rooms. This would allow for the hiring of 2-3 additional practitioners and an administrative staff person. EDIF funds will be used to contribute to the purchase of furniture and equipment. The conditional loan will result in the creation of two new full-time professional positions, and one part-time administrative position. The EDIF agreement is to be prepared by the county attorney will include guarantees and employment reporting requirements. Upon performance of the conditions of the agreement, the conditional loan would revert to a grant.

Wilson, seconded by Commissioner Dumenil the Board agreed to approve the disbursement of \$30,000 from the EDIF fund to Fox Acupuncture and Wellness, Inc. for the purchase of furniture and equipment contingent upon a signed agreement between the EDIF Commission and Fox Acupuncture and Wellness, Inc., outlining the conditions of the agreement and performance of the project in accordance with the application submitted to the EDIF Commission. SOLE SOURCE ZOLL Z-VENT PORTABLE VENTILATOR PURCHASE:

The Queen Anne's County Health Department presented documents to the Board agreeing to purchase portable Zoll Z-vent ventilators and provide these ventilators to the Department of Emergency Services for deployment on their Paramedic Units. These portable ventilators will assist with the increased respiratory incidents they have documented within the pre-hospital Emergency Medical Services arena and will particularly be helpful with patients who have and continue to suffer from long-term Covid-19 symptoms. The cost for eight (8) ventilators is \$82,676.88. Funding will be utilized from the State Health Department COVID-19 grant F795N that was approved and no County funds will be utilized.

Wilson, seconded by Commissioner Moran, the Board unanimously agreed to approve that the Department of Health purchase eight (8) Zoll Z-Vent Portable Ventilators via Zoll Medical Corporation in Chelmsford, MA utilizing State Covid-19 grant funding in the amount of \$82,676.88. BUDGET AMENDMENT #CC-18 – PARKS AND RECREATION ARTIFICIAL TURF:

Ms. Nichole Hepfer presented to the Board Budget Amendment #CC-18. This amendment will establish additional budget authority in the Parks Artificial Turf project 40915 for the design and installation of artificial turf fields at Batts Neck and Church Hill parks. On September 14, 2022 the County Commissioners approved a Parks action item requesting \$2,895,510 using a combination of Parks Impact Fees and Prior Year Fund Balance for the funding of the projects. This budget amendment establishes budget authority to transfer \$700,000 of Parks and Recreation impact fees for this project. The remaining amount of \$2,195,510 will be funded with General Capital projects fund balance.
