RESOLUTION ESTABLISHING THE REGIONAL COUNCIL OF GOVERNMENTS OF QUEEN ANNE'S COUNTY

WHEREAS, Article 25, Section 26A authorizes the governing bodies of any county, city, town or any combination thereof to establish, organize and participate in a council of governments for the purpose of studying area governmental problems of mutual interest and concern;


AND WHEREAS, the undersigned representatives of the respective governing bodies have each elected to establish, organize and participate in a Regional Council of Governments to be known as the Regional Council of Governments of Queen Anne's County.

NOW THEREFORE, BE IT RESOLVED BY the undersigned representatives of the respective governing bodies that the Regional Council of Governments of Queen Anne's County ("Regional Council") be and is hereby established and the each of the undersigned governing bodies shall be a member of and shall designate a representative to such Regional Council.


AND BE IT FURTHER RESOLVED that the Regional Council shall have the power to:

- I. Study such area governmental problems common to two or more members of the council as it deems appropriate, including but not limited to matters affecting health, environment, safety, welfare, education, economic conditions and regional development;
- II. Promote cooperative arrangements and coordinate action among its members;
- III. Make recommendations for review and action to the members and other public agencies that perform functions within the region;
- IV. Adopt bylaws designating the officers of the council and providing for the conduct of its business, including the admission of additional members from time to time.
- V. Accept funds, grants, gifts, and service from the government of the United States or its agencies, from the State of Maryland or its departments, agencies or instrumentalities or from any governmental unit and from private and civil sources; and

The Regional Council shall make a report of its activities to the participating governments at least annually.


